

## **Seeking Medical Director**

Kaua`i Hospice is looking for a full time Medical Director to join our dynamic team. The Medical Director is an essential member of Senior Leadership who will be instrumental in leading Kaua`i Hospice in its continued development of innovative responses to specific palliative and end-of-life care challenges in the areas of patient preferences, patient and family experience, and quality of patient care. The ideal candidate will bring the experience, skills, vision, and desire to pursue developing community- based palliative/supportive care services. Additionally, the Medical Director will be adept at working in an environment that creates partnerships, builds alliances, and leverages existing relationships.

The Medical Director is responsible for the oversight of physician and nurse practitioner services in accordance with accepted standards of practice and in support of its hospice and palliative care philosophy, mission, and purpose. The Medical Director will also provide direct patient care in homecare settings, including skilled nursing and long term care facilities, with a diverse mixture of patients. He/she will work and interact with affiliated medical personnel to assure the seamless delivery of hospice and palliative care.

The Medical Director will serve as hospice and palliative care champion with the following duties: provide clinical oversight of the hospice and palliative care program; review patient eligibility for hospice or palliative service; certify patients' condition to ascertain the need for appropriate care; make home visits to patients for consultation, assessment/intervention, and for hospice recertification; participate in Interdisciplinary Team Meetings and admission and re-certification decisions; act as attending physician for patients referred without a Primary Care Provider (PCP); consult with and update attending physicians and hospice/palliative staff on patient management issues; interact with Long Term Care facility medical directors and physicians; participate in medical and community education efforts to promote the hospice and palliative care philosophy of care and to improve understanding of the services.

Requirements - Licensed as a Doctor of Medicine or Osteopathy in the state of Hawai`i without restriction. Preferred candidate would be board certified in hospice and palliative medicine with expertise, experience, and confidence in hospice care and inpatient and outpatient palliative medicine. Fellowship training desirable but less important than experience. Kaua`i Hospice offers a competitive wage based on experience.
