Objectives and Methodology

- Feb. 4-18, 2017
- Telephone survey
- 525 Hawaii residents, 50 years old or older, who have been in Hawaii for at least six months.
- 321 on Oahu; 204 on Neighbor Islands
- 60% via cellphone; 40% via landline
- Data was weighted by island (Oahu vs. Neighbor Islands) to match the 2015 Census update.






Narrative of Findings



Thinking about End of Life Care

- 63% of Hawaii 50+ year olds have thought about EOL care for themselves
- Most likely: Higher income (\$100K+); more educated (Bachelor's or higher)


Q: Have you ever thought about end of life care for yourself?



End of Life Care Conversation with a Health Care Provider

Most likely: born & raised outside Hawaii, at least a Bachelor's degree

Q: Do you think doctors should discuss end of life care issues with their patients?





EOL Conversation with a Health Care Provider

- 41% spoke with their MD about EOL wishes
- 60+ are more likely than 50-59 to talk with MD about EOL wishes

Q: Have you ever had a conversation with a doctor or other health care provider about your wishes for your end of life care?

End of Life Care Conversation with Health Care Provider: Those who have not had a conversation

- 59% have <u>not</u> talked with MD;
- Notable: 31% want to have this conversation with a MD.


Reasons for not having conversations	
I prefer to speak to my family about my wishes first	76%
I am healthy and do not need to yet	75%
I will trust my health care team to make the decisions	42%
The topic makes me uncomfortable	26%
I am waiting for my doctor to start the conversation	13%
It's bad luck to talk about it	13%
Some other reason (e.g., have something in writing, religious reasons, will do it when time comes, never thought about it)	20%

EOL Conversation with Someone Not a Health Care Provider

63% spoke with someone other than a health care provider about EOL wishes; Most likely: On Oahu and have a Bachelor's degree or higher

Q: Have you had a conversation with at least one other person other than a doctor or other health care provider about your end of life care wishes?






Only had EOL Conversation a Health Care Provider






Advance Health Care Directive



Those who do NOT have HCPOA (55%)

Reasons have never completed the form	
I am healthy and do not need one yet	72%
My spouse or family member will know what I want	61%
I will trust my health care team to make the decisions	44%
The topic makes me uncomfortable	20%
I do not have a person to choose as an agent	16%
It's bad luck to talk about it	11%
If I choose one person, I will upset others	9%
Some other reason (e.g. laziness/procrastination, never thought about it, not the right time)	23%



Wishes for Medical Treatment in Case of Illness or Condition that Makes it Hard to Function

69% gave some thought; Most Likely: more educated (at least a Bachelor's degree); affluent (\$100K+ annual household income)

Q: Before today, how much had you thought about your own wishes for medical treatment, if you were facing an illness or condition that made it hard for you to function in your day-to-day activities?



Conversation in Case of Illness or Condition that Makes it Hard to Function


56% had a conversation about what is important to them if they were facing an illness or condition that made it hard to function in day to day activities



End of Life Care for a Loved One


34% had a loved one die in Hawaii in the last 12 months

84% who had a loved one die in Hawaii in the past 12 months rated care "excellent" or "good"

Conclusions

- Good Foundation already in Hawaii
- Opportunity for education. People believe they don't need ACP because: still healthy, family members will know wishes, trust their fate to family members or their health care team.
- Campaign targets: younger, less educated, as less likely to have conversations or done forms.
- Need to increase health care professionals conversations on ACP. 30% who haven't talked with MD would like to.
